6. Accidental Release Measures

**Personal precautions, protective equipment and emergency procedures:
Environmental precautions:**

Avoid contact with skin and eyes, use appropriate personal protective equipment. Evacuate surrounding areas if necessary. Remove all ignition sources.
Stop leak if without risk. Use appropriate containment to avoid environmental contamination. Prevent from spreading or entering drains, ditches or rivers by using sand, earth or other appropriate barriers.
Local authorities should be advised if significant spillages cannot be contained.

Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately.
Reclaim liquid directly or in an absorbent.
Soak up residue with an absorbent such as clay, sand or other suitable material and dispose of properly.

Precautions for safe handling:

Use in a well ventilated area.
Wear appropriate protective equipment (See Section 8) and clothing to avoid inhalation of fumes or mist and contact with skin and eyes.
Containers not in use should be closed.
Do not smoke.

Conditions for safe storage, including any incompatibilities:

Classified as a Class C2 (COMBUSTIBLE LIQUID) for the purposes of storage and handling.
Store in a cool, well ventilated area away from heat and other sources of ignition, oxidising agents, foodstuffs, and out of direct sunlight.
Keep containers securely sealed and protect against damage.

National Exposure Standards:

No exposure standard has been established, however, the TWA National Occupational Health and Safety Commission (NOHSC) exposure standard for oil mist is 5 mg/m³. As with all chemicals, exposure should be kept to the lowest possible level.
